General Body Meeting (GBM) of IAPSM was held during the National Annual Conference of IAPSM at Science City, Kolkata (11th Feb 2017). Meeting started with the opening remarks of Dr. Ashok Mishra, President, IAPSM and then he requested Dr. A. M. Kadri, Secretary General to conduct further proceedings of the meeting.

	• Members of GBM suggested that a constitutional framework with certain guidelines for			
	minimum activities, regular reports and other programs should be developed.			
	Members of GBM suggested byelaws for chapters may be developed.			
4	Request of Agartala local chapter of IAPSM			
	GBM agreed to give permission for Tripura state chapter in modification.			
	• Majority of GBM said no to Local chapter as of now but guidelines for the same can be			
	developed, looking to the feasibility and usefulness local chapter can be created.			
6	Approval of the Audited Report for the year 2015-16			
	• In previous conference many members requested that it can be presented on projection and			
	lots of papers can be saved, so this time it was scanned and projected on screen			
	In next GBM a proper audited report will be prepared in PPT and displayed on screen			
	• It was suggested by most members that audit report be displayed on website for comments /			
	suggestion of members.			
	Members suggested that we should claim tax rebate from income tax department for TDS paid			

	in IJCM.			
7	Publishing another journal of Community Medicine			
	GBM accepted to the publication of additional journal as CM subject has many sub-specialities.			
	As per the MCI norms, for promotion, articles are required to be published in indexed journal			
	of Association, and current journal of IJCM alone is not sufficient to fulfil expectation of			
	publishing articles of IAPSM members, hence the need for additional journal.			
	IJCM shall remain as only official journal of IAPSM while other journals may be Journal of			
	IAPSM.			
	It was stressed that quality of journal has to be ensured.			
	 It was decided that existing journal published by state chapters may be adopted with quality 			
	scrutiny as well as time to time monitoring by the Committee under CE (IJCM). Also it is			
	decided that committee shall develop the criteria and quality checklist for such journals.			
8	Report by Chief Editor IJCM on IJCM and settling the outstanding financial liabilities			
	Dr. Pradeep Kumar, Chief Editor, IJCM presented the technical and financial report of IJCM in			
	detail.			
	• To settle all the pending dues Approval of GBM for clearing financial liabilities of Rs. 9,20,000			
	from IAPSM savings account.			
	The increase in subscription and processing fees are ratified and approved.			
	Other decisions taken regarding journal are as below.			
	Regarding current MoU with Wolters Kluwer for IJCM, it was felt by the General Body that			
	existing terms and conditions are more in favour of Wolters Kluwer. Also GBM expressed their			
	displeasure regarding non-receipt of the IJCM journal by many members.			
	GBM directed and authorised Chief Editor to have dialogue with Wolters Kluwer and if			
	required may take appropriate actions (in consultation with President & Secretary General)			
	against Wolters Kluwer			
	PG students (Provisional Members) may not be given the hard copy of the IJCM.			
	Voluntary termination of hard copies of IJCM by individual life members and acceptance of			
	Electronic-copy (e-copy) of IJCM can be promoted.			
9	Venue for the next National Conference of IAPSM			
	Proposal of Smt. Kashibai Navale Medical College, Pune to organize next conference for the			
	year 2018 was discussed and approved by the GBM.			
	Next governing council will discuss and finalize norms for selection of the venue of National			
	conference.			
10	Registration fee of Rs 100 at National conference of IAPSM per registered candidate as a fund for			
	IAPSM / IJCM			
	An additional fee of Rs 100 will be collected henceforth at each National conference which will			
	be in addition to the registration fee decided by organizing committee as a fund for IAPSM.			
	This fund will be credited to IAPSM for developmental activities or IJCM as deemed necessary.			
	• It will be the responsibility of organizing committee to transfer this money within 15 days of			
	completion of conference.			
11	Recommendation by the Governing Council			
	Members who are currently holding post at IAPSM (Head office) cannot apply for the Orations,			
	Fellowship, etc during their tenure at head office.			
	Accepted by voice vote by GBM members			
	2. Restructuring of State/Zonal chapters Constitutional amendments for representation in			
	Governing Council based on registered members			
	Coverning Council bused on registered members			

- Accepted by GBM members with voice vote. It is decided that next Governing Council may constitute Constitution Amendment Committee and this can be taken up by the committee.
- 3. State/ Zonal chapters to register and also to get their own PAN card for all financial purpose of state/Zonal chapters and also detailed yearly reports including audit reports to be submitted
- Accepted by GBM members with voice vote.
- 4. Creation of various councils of Past Presidents, Secretary Generals, FIAPSM and Oration awardees
- Accepted by GBM members with voice vote. They can be invited in the Governing Council meetings. However they may not be entitled for TA/DA or accommodation support
- 5. Increasing the members' number in Governing Council and Election fees
- It should be assigned to Constitution Amendment Committee and it can be part of their TOR.
- 6. Publishing the Postal stamp in the name of IAPSM
- It is a good idea. Since cost of Rs 5 lac is to be incurred it is decided that it can be done with due utilization plan and fund availability.
- 7. Increase in fees of election for President, Vice President, Secretary General, Chief Editor and Governing Council members
- Accepted by majority of GBM members. All accepted for 3 times increase in fees for same from existing fees
